(1) Grant of restricted stock units which vest in three installments -- 20% on the first anniversary of the date of grant, 30% on the second anniversary of the date of grant and the remaining 50% on the third anniversary of the date of grant.

(2) Represents the vesting and payout of the first tranche (1/3) of the leveraged restricted stock units granted on March 1, 2013 at 139.1% based on the issuer's stock price performance during the performance period from 1/1/2013-12/31/2013 and includes 644 additional shares above the target number of shares originally reported.

(3) The reporting person made an irrevocable election in November 2012 to satisfy tax withholding obligations relating to the vesting of shares of Common Stock previously awarded through the deduction of shares from the vested amount.

- (4) Each performance share represents a contingent right for the reporting person to receive, on each of the first, second and third anniversaries of the date of grant, a distribution of common stock equal to 0% to 200% of 1/3 of the reported target performance shares based on the issuer's stock price performance during the designated performance periods, as follows: the first distribution is tied to the issuer's one-year stock price performance (1/1/2014 - 12/31/2014); the second distribution is tied to the issuer's two-year stock price performance (1/1/2014 - 12/31/2015); and the third distribution is tied to the issuer's three-year stock price performance (1/1/2014 - 12/31/2016).
