Upon the occurrence of certain events, LTIP Units and OP Units are redeemable, without consideration, for an equivalent number of shares of Issuer's common stock or for the cash value of such shares, at Issuer's election.
- (3) LTIP Units vest 50% on December 31, 2014. The balance of 25,427 LTIP Units vest one-third on each December 31 of 2015, 2016 and 2017.

- (5) LTIP Units will vest 25% on each December 31 of 2015, 2016, 2017, and 2018.
