Unilever NV announces that on 19 July 2007 it purchased 460,045 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 23.650 and euro 23.940 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 52,557 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 81,440,327 Unilever NV ordinary shares in treasury, and has 1,633,287,373 Unilever NV ordinary shares in issue (excluding treasury shares).
