Unilever NV announces that on 29 November 2007 it purchased 61,612 Unilever NV ordinary shares (in the form of depository receipts thereof) at prices between euro 23.720 and euro 23.860 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 125,547 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, hold 115,722,648 Unilever NV ordinary shares in treasury and has 1,599,005,052 ordinary NV shares in circulation.
