Unilever NV announces that on 18 February 2008 it purchased 1,033,108 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 20.570 and euro 20.990 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 2,475 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 131,146,473 Unilever NV ordinary shares in treasury, and has 1,583,581,227 Unilever NV ordinary shares in issue (excluding treasury shares).
