Item 1.01 Entry into a Material Definitive Agreement.

On April 1, 2009, the Registrant's wholly-owned subsidiary, Endo Pharmaceuticals Inc. (Endo) and Ventiv Commercial Services, LLC (Ventiv) (collectively, the Parties) amended the Sales Representative Services Agreement between the Parties dated as of April 1, 2008 (the April 2009 Amendment). Under the terms of the April 2009 Amendment, the Parties modified the termination rights allowing Endo to terminate the Sales Representative Service Agreement, at our sole discretion, at any time upon 30 days prior written notice.
