**Explanatory Statement**

On October 30, 2002, Chordiant Software, Inc., a Delaware corporation (the Registrant ), filed a Registration Statement on Form S-8 (File No. 333-100843) (the Registration Statement), which registered 3,508,881 shares of the Registrant's common stock, par value \$0.001 per share (the Common Stock ) reserved for issuance under the 1999 Equity Incentive Plan and the 1999 Non-Employee Directors' Stock Option Plan (collectively, the 1999 Plans ).
