**ChipMOS REPORTS JULY 2014 REVENUE**

**Hsinchu, Taiwan, August 8, 2014** - ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and testing services ( OSAT ), today reported its unaudited consolidated revenue for the month of July 2014.

Revenue for the month of July 2014 was NT\$1,943.9 million or US\$64.7 million, an increase of 8.0% from the month of June 2014 and an increase of 13.2% from the same period in 2013. All U.S. figures in this release are based on the exchange rate of NT\$30.06 to US\$1.00 as of July 31, 2014.
