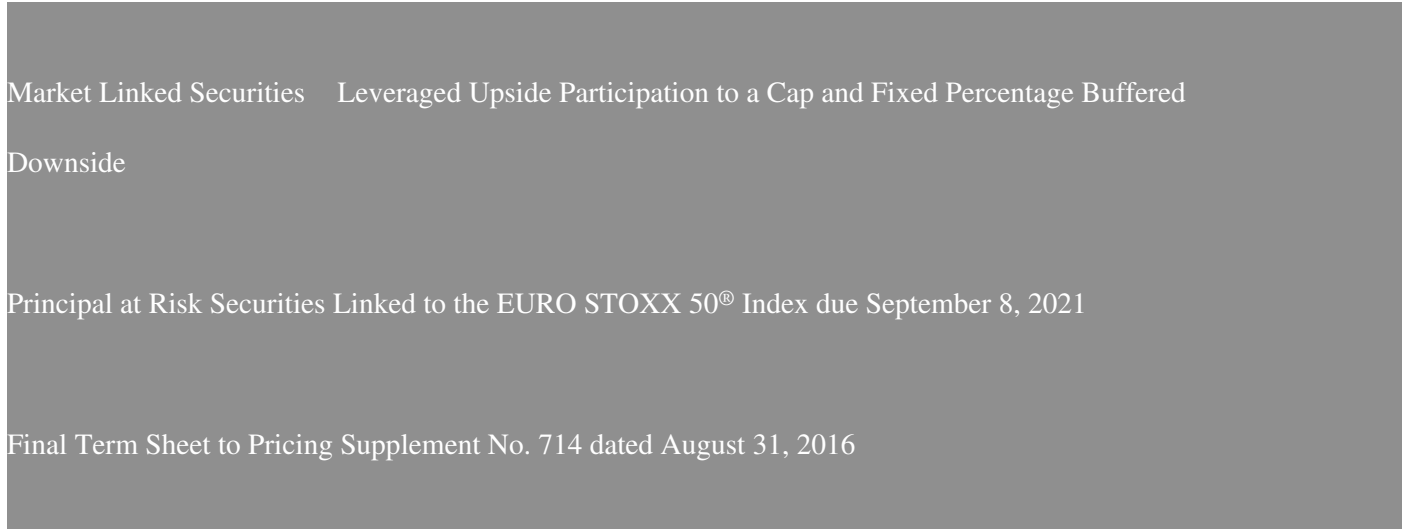

Investment description

Linked to the EURO STOXX 50<sup>®</sup> Index

Unlike ordinary debt securities, the securities do not pay interest or repay a fixed amount of principal at maturity. Instead, the securities provide for a payment at maturity that may be greater than, equal to or less than the original offering price of the securities, depending on the performance of the Index from its starting level to its ending level.

The payment at maturity will reflect the following terms:

o **If the level of the Index increases:**

You will receive the original offering price plus 200% participation in the upside performance of the Index, subject to a maximum total return at maturity of 58% of the original offering price

o **If the level of the Index decreases but the decrease is not more than 20%:**

You will be repaid the original offering price

o **If the level of the Index decreases by more than 20%:**

You will receive less than the original offering price and will have 1-to-1 downside exposure to the decrease in the level of the Index in excess of 20%

Investors may lose up to 80% of the original offering price

How the redemption amount is calculated

The redemption amount payable at maturity will be determined as follows:

If the ending level is greater than the starting level, the redemption amount will be equal to the lesser of:

(i) \$1,000 *plus*

$$\$1,000 \times \frac{\text{ending level} - \text{starting level}}{\text{starting level}} \times \text{participation rate} \quad ; \text{ and}$$

(ii) the capped value

If the ending level is less than or equal to the starting level, but greater than or equal to the threshold level, the redemption amount will be equal to \$1,000

If the ending level is less than the threshold level, the redemption amount will be equal to \$1,000 *minus*

$$\$1,000 \times \frac{\text{threshold level} - \text{ending level}}{\text{starting level}}$$

**If the ending level is less than the threshold level, you will receive less, and possibly 80% less, than the original offering price of your securities at maturity.**
