This Amendment No. 12 (this Amendment ) amends and supplements the Schedule 13D filed on July 1, 2015 (the Original Filing ), as amended by Amendment No. 1 filed on October 5, 2015 ( Amendment No. 1 ), Amendment No. 2 filed on October 23, 2015 ( Amendment No. 2 ), Amendment No. 3 filed on December 17, 2015 ( Amendment No. 3 ), Amendment No. 4 filed on January 20, 2016 ( Amendment No. 4 ), Amendment No. 5 filed on February 19, 2016 ( Amendment No. 5 ), Amendment No. 6 filed on March 1, 2016 ( Amendment No. 6 ), Amendment No. 7 filed on March 11, 2016 ( Amendment No. 7 ), Amendment No. 8 filed on May 10, 2016 ( Amendment No. 8 ), Amendment No. 9 filed on May 20, 2016 ( Amendment No. 9 ), Amendment No. 10 filed on November 22, 2016 ( Amendment No. 10 ) and Amendment No. 11 filed on December 6, 2016 ( Amendment No. 11 ), and together with the Original Filing and Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4, Amendment No. 5, Amendment No. 6, Amendment No. 7, Amendment No. 8, Amendment No. 9 and Amendment No. 10, the Schedule 13D ) by the Filing Person relating to the ordinary shares, without nominal value (the Shares ), of Telecom Italia S.p.A., a company formed under the laws of the Republic of Italy (the Issuer or the Company ). Information reported in the Schedule 13D remains in effect except to the extent that it is amended, supplemented, restated or superseded by information contained in this Amendment. Each capitalized term used herein but not defined in this Amendment shall have the meaning assigned to such term in the Schedule 13D.

**Item 5 of the Schedule 13D is hereby amended as follows:**

- (a) As of the date of this Statement, the Filing Person beneficially owned 3,637,328,030 Shares, constituting 23.925% of the outstanding Shares. The percentage of Shares owned is based upon 15,203,122,583, as reported by the Issuer on July 11, 2016 and supplemented by its press release issued on November 11, 2016, relating to the issuance by the Company, on November 15, 2016, of 1,702,850,712 Shares in connection with the mandatory conversion at maturity of convertible bonds.
- (b) The number of Shares as to which there is sole power to vote or direct the vote, shared power to vote or direct the vote, sole power to dispose or direct the disposition, or shared power to dispose or direct the disposition for the Filing Person is set forth on the cover page in items 7 through 10.
- (c) On December 6, 2016, the Filing Person filed a Form 13D/A with the Securities and Exchange Commission which inadvertently contained an error in the percentage of outstanding Shares of the Issuer held by the Reporting Person. The correct percentage of outstanding Shares held by the Reporting Person as of December 5, 2016, was, as reported in item 13 above, 23.925% and not 24.19%.
