**EXPLANATORY NOTE**

This Registration Statement on Form S-8 is filed for the purposes of registering 1,365,679 additional shares of common stock, par value \$0.001 per share ( Common Stock ) of Brightcove Inc. (the Registrant ) that may be issued pursuant to the Brightcove Inc. 2012 Stock Incentive Plan (the 2012 Plan ). The number of shares of Common Stock reserved and available for issuance under the 2012 Plan is subject to an automatic annual increase on each January 1, by an amount equal to 4% of the number of shares of the Registrant s Common Stock outstanding on the immediately preceding December 31, unless the Registrant s overhang exceeds 30% on such December 31. Accordingly, on January 1, 2017, the number of shares of Common Stock reserved and available for issuance under the 2012 Plan increased by 1,365,679. This Registration Statement hereby registers these additional 1,365,679 shares of Common Stock. The additional shares are of the same class as other securities relating to the 2012 Plan for which the Registrant s registration statement filed on Form S-8 on March 7, 2012 (SEC File No. 333-179966) is effective. The information contained in the Registrant s registration statement on Form S-8 (SEC File No. 333-179966) is hereby incorporated by reference pursuant to General Instruction E.
