Amended to include 10.681 shares acquired through the reinvestment of dividends on June 30, 2006, in the trust account at a price of \$81.9283 per share.

- (2) The phantom stock units convert to the common stock's cash value on a one-for-one basis.
- (3) The phantom stock units were accrued under the Johnson Controls Directors' Deferred Compensation Plan and are to be settled 100% in cash upon the reporting person's retirement.
- (4) Pursuant to a domestic relations order and Rule 16a-1(a)(2), for purposes of Section 16 of the Securities Exchange Act of 1934, the reporting person disclaims beneficial ownership of 25,058.43 units of the phantom stock in the Deferred Compensation Plan account.
