- (1) Class A Common Stock on a one-for-one basis upon distribution. Distribution of shares of Class A Common Stock occurs the first day of the calendar month after a director's service on the Board terminates or upon another date or dates designated by the director pursuant to the Omnibus Plan.
- (2) Includes: (1) the 33,229.50 shares of deferred stock units previously granted pursuant to the Company's Omnibus Plan, (2) 2000 shares of Class A Common Stock and (3) 926.54 shares of deferred stock units being reported.
