(1) Each restricted unit represents a contingent right to receive the cash value of one share of Fluor common stock.

(4) These phantom units were acquired under the Fluor Corporation Deferred Directors' Fees Program and are to be settled in cash upon the reporting person's termination of service as a director, death or disability in a single lump sum payment or annual installment payments over a period of two to twenty years. Units are immediately exercisable because they may be transferred into an alternative investment. However, up to 72.9 shares would be forfeited upon such transfer prior to January 1, 2011.
