The shares vest 50% after 30 months and the remaining 50% after 60 months, subject to earlier forfeiture if Fiscal 2009 operating profit is less than 80% of the target operating profit goal under the Company's Fiscal 2009 Management Incentive Plan.
- (2) The stock options were issued under The Home Depot, Inc. 2005 Omnibus Stock Incentive Plan and vest in 25% increments beginning on the second anniversary of the grant date.
