- (1) These shares reflect the \$40,000 annual Trustee share award the number of shares of which is calculated based upon the closing price on June 2, 2009 of \$7.15. Shares will vest ratably over three years: 1/3 on June 2, 2010; 1/3 on June 2, 2011 and 1/3 on June 2, 2012.
The shares were acquired on May 19, 2009, and constitute a "small acquisition" under Rule 16a-6(a) and are thus eligible for deferred reporting. The reporting person has elected to voluntarily report the acquisition of these shares in this Form 4 as opposed to a subsequent Form 5.
- (2) This is an exempt transaction and reports the first of two separate bona fide gifts made by the reporting person of 40 shares to each of two separate donees.
- (3) This is an exempt transaction and reports the second of two separate bona fide gifts made by the reporting person of 40 shares to each of two separate donees.
