The shares represent restricted stock units that were received as an award, for no consideration. The restricted stock unit shall vest as to (1) 25% of the shares on September 19, 2012 and 12.5% of the shares every six months thereafter, such that the shares are fully vested on approximately the four (4) year anniversary of the date of grant.
