- (2) Pursuant to elections made by the reporting person with respect to compensation earned as a executive officer of PNC, 6165 phantom stock units became payable in cash on January 2, 2013.

Shares of PNC common stock are not directly allocated to SISP participants, but instead are held in a unitized fund, approximately 98% of which consists of PNC common stock, and the remainder of which is invested in a money market fund. The amount of securities beneficially owned reflects 67 shares indirectly acquired for the account of the reporting person under the SISP in transactions exempt from reporting
