- (1) All historical share data in this Form 4 have been restated to reflect a one-for-four reverse stock split effective as of October 11, 2012. As previously reported, on February 23, 2011, the reporting person received a grant of 2,250 restricted units that vest ratably on each of the first, second and third anniversaries of the date of grant. The first and second anniversaries occurred on February 23, 2012 and February 22, 2013, respectively, resulting in the vesting and settlement of 750 shares of common stock in each case. The third anniversary of this grant occurred on February 21, 2014, resulting in the vesting and settlement of 750 shares of common stock as shown in Table I and Table II. Restricted units are settled in shares of the Company's common stock upon vesting.
- (3) Restricted units convert into common stock on a one-for-one basis.
- (4) Shares withheld for payment of taxes upon vesting of restricted units in accordance with Rule 16b-3.
