(1) The stock option vests as follows: 100,000 option shares vest on the one-year anniversary of grant, 300,000 option shares vest in equal monthly amounts over a 36-month period, commencing on the 13th month anniversary of the date of grant, and 200,000 option shares vest in accordance with performance-based criteria established by the Compensation Committee of the Board of Directors. The vesting of the stock option is subject to the Reporting Person's continued service with the Company through the applicable vesting dates.
