- 1,240 shares were withheld by the issuer to satisfy income tax withholding requirements related to the lapsing of restrictions on (a) 279 shares of restricted stock awarded to the reporting person on May 18, 2017 (Form 4 filed on 5/22/2017); (b) 440 shares of restricted stock awarded to the reporting person on May 20, 2016 (Form 4 filed on 5/24/2016); (c) 581 shares of restricted stock awarded to the reporting person on June 10, 2015 (Form 4 filed on 5/10/2016); (d) 858 shares of restricted stock awarded to the reporting person on 6/03/2014 (Form 4 filed on 5/7/2015) and (e) 948 shares of restricted stock awarded to the reporting person on 8/12/2013 (Form 4 filed on 5/08/2014).
