These shares are represented by restricted stock units. The units vest 40% on the two year anniversary of the date of grant and 20% vest on the third, fourth and fifth anniversaries of the date of grant. Upon vesting, the restricted stock units will be paid out in whole shares of common stock.

- (3) The options vest 10% on the six month anniversary of the date of grant and the remaining balance vests monthly thereafter. The option is fully vested five years after the date of grant.
