Due to the two for one stock split on June 8, 2017, additional reported shares would now be an additional 20 shares. These under reported shares were also excluded in the direct ownership totals on four subsequent Form 4s filed by the Reporting Person on March 14, 2017, June 12, 2017, September 11, 2017, and December 12, 2017. As of January 31, 2018, Reporting Persons total direct ownership is 32,119 shares.
