 - (1) The number of underlying securities is based on the stock fund balance on October 2, 2012. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on an October 2, 2012, stock fund price of \$27.55 per share. Includes a company match of 426.829 shares on February 16, 2012 at a price of \$34.44 per share.
 - (2) Fifty percent of the options vest after two years and the remaining 50% vests after three years.
