#### Item 2.02 Results of Operations and Financial Condition.

On March 6, 2008, STAAR Surgical Company (the "Company") issued a press release announcing its financial results for the quarter ended and fiscal year ended December 28, 2007. A copy of the press release is attached as Exhibit 99.1 to this Report and is incorporated herein by this reference.

The press release states that "During the fourth quarter . . . we announced the completion of the acquisition of all other shareholders' interests in our Japanese joint venture, Canon Staar Co., Inc." The Company notes that the acquisition of those interests was actually announced in the first quarter of fiscal year 2008, on January 4, 2008, and that the closing of the transaction on December 29, 2007 also took place in the Company's 2008 fiscal year.
