  - (1) Represents restricted stock which vests five years from the date of grant and is subject to forfeiture upon termination of employment unless certain conditions arise pursuant to Mr. Lybarger's employment agreement. The 2,419 shares represents an adjustment to a previous grant of restricted shares based on performance objectives obtained by the company.
  - (2) Represents restricted stock which vests five years from the date of grant.
  - (3) For options granted in any one year, one-seventh of the options of such grant vest and become exercisable on the grant date of the anniversary each year commencing on the first anniversary after the grant.
  - (4) Options expire three years after vesting.
