- The number of underlying securities is based on the stock fund balance on September 30, 2009. The actual number of shares issuable
- (1) upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a September 30, 2009, stock fund price of \$25.56 per share.
 - (2) Fifty percent of the option vests after two years and the remaining fifty percent after three years.
- Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were
- (3) awarded under the Johnson Controls Executive Deferred Restricted Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company, subject to vesting provisions.
 - (4) Includes 51.147 phantom stock units acquired through the reinvestment of dividends on October 2, 2009, at \$23.77 per phantom stock unit.
