This Amendment No. 1 to Schedule 13D ("Amendment No. 1") amends and supplements the prior statement on Schedule 13D (the "Statement") as filed by Giant Leap International, Ltd. (the "Reporting Person") related to the common stock, par value \$ 0.0001 per share (the "Common Stock"), of BIO-key International, Inc., a Delaware corporation (the "Issuer"). Unless specifically amended hereby, the disclosures in the Statement remain unchanged. Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Statement.

**Item 1. Security and the Issuer.**

There are no amendments to Item 1 of the Statement pursuant to this Amendment No. 1.

**Item 2. Identity and Background**

There are no amendments to Item 2 of the Statement pursuant to this Amendment No. 1.

**Item 3. Source and Amount of Funds or Other Consideration.**

There are no amendments to Item 3 of the Statement pursuant to this Amendment No. 1.

**Item 4. Purpose of Transaction.**

Item 4 of the Statement is hereby amended by the addition of the following:

As a result of the transactions described in Item 5 below, the Reporting Person no longer owns any shares of Series B-1 Convertible Preferred Stock (the "Series B-1 Shares").

**Item 5. Interest in Securities of the Issuer.**

Item 5(a) of the Statement is hereby amended and restated as follows:

(a) The Reporting Person beneficially owns 958,289 shares of Common Stock. The shares of Common Stock beneficially owned by the Reporting Person constitute 7.6% of the Issuer's outstanding shares of Common Stock.

Item 5(c) of the Statement is hereby amended by the addition of the following:

(c) On May 23, 2018, the Reporting Person delivered a conversion notice to the Issuer to convert the remaining 720 Series B-1 Shares owed by the Reporting Person. Each Series B-1 Share had an original issue price of \$100.00 and was convertible into shares of the Issuer's common stock at a conversion price of \$3.60 per share. The forgoing conversion resulted in the issuance of 20,000 shares of Common Stock.

On May 23, 2018, the Reporting Person entered into a securities purchase agreement with the Issuer to purchase 2,978 shares of Common Stock in consideration of the conversion of an accrued dividend payable on the Series B-1 Shares owed by the Reporting Person in the amount of \$10,721 resulting in a per share purchase price of \$3.60.

**Item 6. Contracts, Arrangements, Understandings or Relationships with Respect to Securities of the Issuer.**

Item 6 of the Statement is hereby amended by the addition of the information set forth in Item 4 above.
