As the investment adviser to the Funds, AWM holds sole voting and investment power over 301,608 Shares of common stock of the Issuer (the Shares) held by CAYMAN, 862,319 Shares held by SSFQP and 333,216 Shares held by SSPE.
- (3) Austin W. Marxe (Marxe), David M. Greenhouse (Greenhouse) and Adam C. Stettner (Stettner) are the controlling principals of AWM. The reporting person disclaims beneficial ownership of the Shares, except to the extent of its pecuniary interest therein.
