AWM Investment Company, Inc., a Delaware corporation (AWM), is the investment adviser to Special Situations Fund III QP, L.P. (SSFQP), Special Situations Private Equity Fund, L.P. (SSPE), Special Situations Technology Fund, L.P. (TECH) and Special Situations Technology Fund II, L.P. (TECH II and together with SSFQP, SSPE and TECH, the Funds). As the investment adviser to the Funds, AWM holds sole voting and investment power over 1,841,890 shares of Common Stock of the Issuer (the Shares) held by SSFQP, 589,117 Shares held by SSPE, 214,396 Shares held by TECH and 1,333,554 Shares held by TECH II.
