As calculated in accordance with Rule 13d-3 of the Securities Exchange Act of 1934, as amended, (i) Sabby Healthcare Volatility Master Fund, Ltd. beneficially owns 182,750 shares of the Issuer's common stock (Common Stock), representing approximately 0.85% of the Common Stock, and (ii) Sabby Management, LLC and Hal Mintz each beneficially own 217,500 shares of the Common Stock, representing approximately 1.02% of the Common Stock. Mr. Mintz indirectly owns 217,500 shares of Common Stock in his capacity as manager of Sabby Management, LLC.
