The holders of the following securities (the "Securities") have been notified by the Issuers of the upcoming redemption of the Securities on 31 December 2017:

A. the US\$750,000,000 6.80% Non-cumulative Trust Preferred Securities issued by the Trust pursuant to the Amended and Restated Declaration of Trust dated 5 December 2002 of the Trust (the "Declaration of Trust") (ISIN Code: XS0159056208) (the "TPS"); and

B. the US\$750,001,000 Fixed Rate Callable Subordinated Notes due 2042 issued by the Bank pursuant to the Trust Deed dated 5 December 2002 (ISIN Code: XS0158336296) (the "Subordinated Notes").

As a result of previous public tender offers for the TPS, the Bank already holds US\$264,142,000 of the TPS.

The Bank has elected to redeem the Securities on 31 December 2017 in accordance with the Conditions of the Subordinated Notes. The TPS are being redeemed, pursuant to Section 8.03 of the Declaration of Trust, as a result of the Partnership exercising its rights to redeem all of the Partnership Preferred Securities under Section 5.03(e)(ii) of the Partnership Agreement. Terms used but not defined herein shall have the meaning given to them in the relevant notice of redemption or, if not defined therein, the meaning given to them in the Declaration of Trust or the Partnership Agreement.
