- Pursuant to a resolution adopted by the Board of Directors of the Issuer on June 22, 2018, and to reflect the change in timing of stock awards to non-employee directors (as described in the 2018 Proxy Statement), each non-employee director received a grant of 419 shares of common stock for the period starting January 1, 2018 through April 27, 2018, which was the date of the 2018 Annual Meeting.
