(1) On March 21, 2013, 3,000 Restricted Stock Units vested and were settled for an equal number of shares of Stryker Common Stock.

The restricted stock units vest as to 25% on March 21, 2013; 25% on March 21, 2014; and 50% on March 21, 2015. Vesting will be accelerated in the event of termination of employment by reason of disability or death but will otherwise cease upon termination of employment or a significant decrease in the reporting person's role and/or responsibilities with Stryker.
