 - (2) Restricted shares granted under the NIKE, Inc. 1990 Stock Incentive Plan. The restrictions lapse with respect to one-third of the shares on each of the first three anniversaries of the date of grant; provided that if NIKE terminates Mr. Ayre's employment without cause prior to the full vesting of the shares, his right to sell the shares shall vest 100% upon such termination.
 - (3) Restricted shares granted under the NIKE, Inc. 1990 Stock Incentive Plan. The restrictions lapse with respect to one-half of the shares on each of the first two anniversaries of the date of grant; and upon any termination of employment, any shares as to which the restrictions have not expired shall be forfeited to NIKE for cancellation and become authorized but unissued shares.
 - (4) Option granted on 7/20/2007 and becomes exercisable with respect to 25% of the shares on each of the first four anniversaries of the date of the grant.
