Pursuant to terms of the Nonemployee Directors' Deferred Compensation Plan approved by the board of directors on February 11, 2000 and amended and restated on April 7, 2006, Mr. Brown elected to receive his 2011 board of directors retainer, meeting fees and stock award in Franklin Electric Co., Inc. common stock, issuance of such shares deferred until he retires or otherwise leaves the board of directors (e.g. Stock Units). On May 6, 2011, Mr. Brown was credited with 0 Stock Units for dividends that would have been paid on such deferred shares and 1162.79 stock units for his annual retainer fee, 1976.74 stock units for his annual stock award, and 34.88 stock units for attending a board meeting. At distribution, Mr. Brown may elect pursuant to the terms of the Plan to receive his deferred compensation either in shares of Franklin common stock or in cash.
