  - (1) On December 19, 2012, the reporting person had 191 shares withheld and cancelled to cover minimum required tax withholdings due to the vesting of shares of restricted stock. These share cancellations are shown on Table I as dispositions (Transaction Code "D" in Column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in Column 3.
  - (2) On December 20, 2012, the reporting person had 192 shares withheld and cancelled to cover minimum required tax withholdings due to the vesting of shares of restricted stock. These share cancellations are shown on Table I as dispositions (Transaction Code "D" in Column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in Column 3.
  - (3) Routine acquisition under the NFG 401(k) Plan Trust, exempt under Rule 16b-3(c), a non-reportable transaction.
  - (4) The stock appreciation right becomes exercisable in three approximately equal annual installments as follows: 4,215 on December 19, 2013; 4,216 on December 19, 2014; and 4,216 on December 19, 2015.
