On August 23, 2016, UDR, Inc., a Maryland corporation (the “Company”), issued \$300,000,000 aggregate principal amount of the Company’s 2.950% Medium-Term Notes, Series A due 2026, which are fully and unconditionally guaranteed by United Dominion Realty, L.P.
