ITEM 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT

On July 1, 2014, our wholly owned subsidiary, Sunrise Coal, LLC, signed a Stock Purchase Agreement with Vectren Corporation to purchase Vectren Fuels, Inc., a wholly owned coal mining subsidiary of Vectren Corporation, for \$296 million plus working capital adjustments not to exceed \$325 million. We expect to close on or before September 1, 2014. As part of the agreement, Sunrise agreed to pay a \$20 million termination fee if financing cannot be procured and closing does not occur on or before November 26, 2014.
