**TEVA ANNOUNCES GLOBAL IN-MARKET SECOND QUARTER SALES OF COPAXONE<sup>&reg</sup>  
INCREASED 22% TO \$353 MILLION**

**Jerusalem, Israel, August 2, 2006** - Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) announced today, in conjunction with the release of the Sanofi-Aventis group`s financial results, that global in-market sales of Copaxone<sup>&reg</sup> reached a record \$353 million in the second quarter ending June 30, 2006. Once again, Copaxone<sup>&reg</sup> was the fastest growing multiple sclerosis (MS) therapy worldwide, with a growth of 22% in sales over the comparable quarter of 2005.

U.S. sales in the second quarter of 2006 increased 19% over the second quarter of 2005 to \$231 million. According to IMS data in the US, Copaxone<sup>&reg</sup> continued to strengthen its position as market leader reaching a market share of 33.9% in TRx and 34.9% in NRx in June 2006.

Outside the U.S., mainly in Europe, Copaxone<sup>®</sup> continues to be the fastest growing multiple sclerosis therapy with growth of 26% over the second quarter of 2005, reaching sales of \$123M.

Teva Pharmaceutical Industries Ltd., headquartered in Israel, is among the top 20 pharmaceutical companies in the world and is the leading generic pharmaceutical company. The company develops, manufactures and markets generic and innovative human pharmaceuticals and active pharmaceutical ingredients, as well as animal health pharmaceutical products. Over 80% of Teva's sales are in North America and Europe.
