Terms of the Notes

The Contingent Income Auto-Callable Yield Notes Linked to the Least Performing of the Dow Jones Industrial Average® and the Russell 2000® Index (the “Notes”) provide a quarterly Contingent Coupon Payment of between [\$15.00 and \$17.50] (set on the pricing date) on the applicable Contingent Payment Date if, on the related quarterly Observation Date, the Observation Value of **each** Underlying is greater than or equal to its Coupon Barrier. Beginning in April 2020, if the Observation Value of **each** Underlying is greater than or equal to its Starting Value on any Observation Date (other than the final Observation Date), the Notes will be automatically called, in whole but not in part, at an amount equal to 100% of the principal amount, together with the relevant Contingent Coupon Payment. No further amounts will be payable following an Automatic Call. If the Notes are not automatically called, at maturity you will receive the Redemption Amount, calculated as described under “Redemption Amount Determination”.

Term: Approximately 3.5 years, unless previously automatically called.
Underlyings: The Dow Jones Industrial Average® and the Russell 2000® Index
Pricing and Issue Dates*: April 26, 2019 and April 30, 2019, respectively

Observation Dates *: Quarterly. Please see the Preliminary Pricing Supplement for further details.

Coupon Barrier: For each Underlying, 75% of its Starting Value.

Threshold Value: For each Underlying, 75% of its Starting Value.

Contingent Coupon Payment*: If, on any quarterly Observation Date, the Observation Value of each Underlying is greater than or equal to its Coupon Barrier, we will pay a Contingent Coupon Payment of between [\$15.00 and \$17.50] per \$1,000 in principal amount (a rate of between [1.50% and 1.75%] per quarter or between [6.00% and 7.00%] per annum) on the applicable Contingent Payment

Contingent Coupon Payment*: Date

Beginning in April 2020, all (but not less than all) of the Notes will be automatically called if the Observation Value of each Underlying is greater than or equal to its Starting Value on any Observation Date (other than the final Observation Date). If the Notes are automatically called the Early Redemption

Automatic Call: Amount will be paid on the applicable Contingent Payment Date.

Early Redemption Amount: For each \$1,000 principal amount of Notes, \$1,000 plus the applicable Contingent Coupon Payment.

Initial Estimated Value Range: \$940-\$970 per Note.

Underwriting Discount:* \$30.00 (3.00% of the public offering price) per Note.
