 - (1) Disposed of pursuant to the Agreement and Plan of Merger by and among the issuer, Tornier N.V., Trooper Holdings Inc., and Trooper Merger Sub Inc., which became effective on October 1, 2015, in exchange for 7,702 Wright Medical Group N.V. ("Wright N.V.") ordinary shares having a market value of \$20.39 per share at the effective time of the merger.
 - (2) The employee stock option vests in equal annual installments over a period of four years after the grant date.
 - (3) This option was assumed by Wright N.V. in the merger and replaced with an option to purchase 34,626 Wright N.V. at a price of \$30.08 per share.
