Each of ESW and Mr. Liemandt disclaim Section 16 beneficial ownership of the reported shares except to the extent of their respective pecuniary interest therein, if any.

(1) Represents a weighted average sales price per share. These shares were sold in multiple transactions at prices ranging from \$35.00 to \$35.07.
