As of the date of this filing, Drawbridge Global Macro Master is the beneficial owner of (i) 2,554,907 shares of Common Stock owned outright and (ii) 1,008,000 shares of Common Stock currently issuable upon the exercise of certain warrants (the "Warrants"), the terms of which are subject to limitations such that the Warrants may not be excercised if doing so would result in the Reporting Person having aggregate beneficial ownership of more than 9.99% of the total issued and outstanding shares of Common Stock (the "Ownership Limitation"). As of the date of this filing, Drawbridge Investment Partners is the beneficial owner of (i) 486,649 shares of Common Stock owned outright and (ii) Warrants to purchase 192,000 shares of Common Stock subject to the Ownership Limitation.
