(1) This filing amends the Forms 4 filed by the reporting person on December 7, 2009 and December 24, 2009. The Form 4 filed on December 7, 2009 reported a gift disposition of 41,662 shares from the reporting person's living trust. This transaction was a mistake by the reporting person's broker and has since been rescinded through the broker's error account. As of December 3, 2009, the reporting person's living trust beneficially owned 301,490 shares of common stock. As of December 23, 2009, the date of the transaction listed on the reporting person's most recently filed Form 4, and subsequent to the gift of 19,259 shares made on that date, the reporting person's living trust beneficially owned 282,231 shares of common stock.
