Partners, as the general partner of BVF and BVF2, the manager of BVLLC and the investment adviser of ILL10, may be deemed to beneficially own the 2,110,482 shares of Common Stock beneficially owned in the aggregate by BVF, BVF2, BVLLC and ILL10.
