On March 9, 2006, the Board of Directors of Hallmark Financial Services, Inc. (the "Company") elected Mark J. Morrison as President of the Company, effective as of April 1, 2006. Mark E. Schwarz, Chairman and Chief Executive Officer of the Company, previously held the additional title of President. Mr. Morrison will also continue to serve as Chief Operating Officer and Chief Financial Officer of the Company. Mr. Morrison has no employment agreement with the Company and serves in all positions at the will of the Board of Directors.

Mr. Morrison, age 46, became Executive Vice President and Chief Financial Officer of the Company in March, 2004, and was given the additional responsibilities of Chief Operating Officer in April, 2005. He has been employed in the property and casualty insurance industry since 1993. Prior to joining the Company, he had since 2001 served as President of Associates Insurance Group, a subsidiary of Travelers Property Casualty Corp. From 1996 through 2000, he served as Senior Vice President and Chief Financial Officer of Associates First Capital Corporation. From 1995 to 1996, Mr. Morrison served as Controller of American Eagle Insurance Group, and from 1993 to 1995 was a Director in the Credit Suisse Group of Republic Insurance Group. From 1991 to 1993, he served as a Director of Anthem Life Insurance Company. Mr. Morrison began his career as a public accountant with Ernst & Young, LLP from 1982 to 1991, where he completed his tenure as a Senior Manager.
