On January 14, 2014, The Wendy's Company, a Delaware corporation ("Wendy's"), issued a press release stating that it is commencing a modified "Dutch auction" tender offer to repurchase shares of its common stock for an aggregate purchase price of up to \$275.0 million. The offer will be made solely by an Offer to Purchase and the related Letter of Transmittal, as they may be amended or supplemented.
