It is anticipated that the Registrant will report net revenues for the year ended December 31, 2001, of approximately \$74.5 million, an increase of approximately \$15.4 million over revenues for the year ended December 31, 2000, of approximately \$59.1 million.

It is anticipated that the Registrant will report a net loss from continuing operations for the year ended December 31, 2001, of approximately \$602,000. After giving effect to the recognition by the Registrant of approximately \$145,000 for preferred stock dividends in 2001, it is anticipated that the Registrant will report for the year ended December 31, 2001, a net loss of approximately \$747,000 (or approximately \$.03 per share). In comparison, the Registrant's net loss for the year ended December 31, 2000, was approximately

\$762,000 (or approximately \$.04 per share), which included preferred stock dividends of approximately \$206,000 which were recorded for 2000.
