Capital Guardian Trust Company, a bank as defined in Section 3(a)(6) of the Act is deemed to be the beneficial owner of 1,889,000 shares or 5.3% of the 35,848,000 shares of Common Stock believed to be outstanding as a result of its serving as the investment manager of various institutional accounts.
